Date & Venue of Award Function : Following dates have been proposed for organizing Award Function :

Proposed dates : 24th February 2023 or 4th March 2023.

Venue : to be decided. Mr.Rajvanshi suggested to check the venue of NCPA, next to Trident Hotel.

Applications : Applications of Award Function are under scrutiny, VC informed that the same will be scrutinized and shall be sent to committee soon.

Sponsorship : Contact the following for sponsorship
