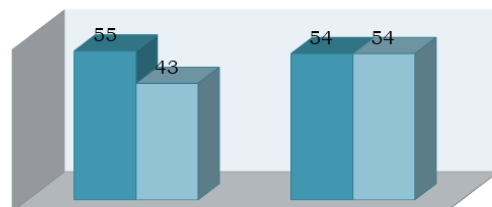

### High Disposal Rate (Mumbai)

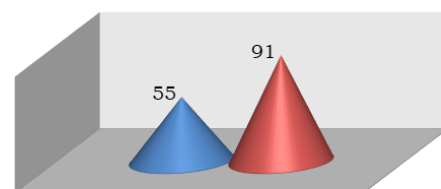

### Expeditious Proceedings (Mumbai)

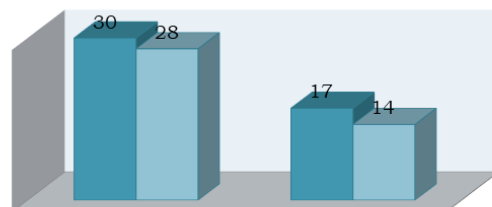

### High Disposal Rate (New Delhi)

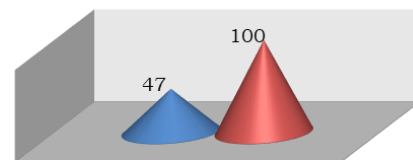
