 - Construction
 - Manufacturing (including oil & gas)
 - Mining
 - Power Generation

Instructions

- The application for the award is for a single unit (site specific in case of construction and mining).
- Multiple units/sites of a single organization are eligible to apply for Awards.
- The Awards are given in three categories in the four sectors mentioned below:
 - Large Sized Organization (Organization having either turnover or investment excluding working capital of more than Rs 500 crore)
 - Medium Sized Organization (Organization having either turnover or investment excluding working capital between Rs 100 crore to Rs 500 crore).
 - Small Scale Organization (Organization having turnover & investment excluding working capital, both less than Rs 100 crore)
- For the award, category size of the parent organization is considered and not of the unit.

Three Stages of Evaluation Process

- Application evaluation
- On-site / Virtual Site Assessment for qualifying units (Please note that plant audit expenses of auditors related to traveling and accommodation, if on-site audit is done, will be borne by the qualifying unit. Also each audited unit need to pay an additional fee of Rs 13,000 /- per man day (inclusive of all taxes) to FICCI as the auditor fee for the on-site / virtual site assessment of its unit)
- Jury Selection by the presentation of Qualifying sites after on-site / virtual site assessment
