Q2 FY21 Business Update

16th October 2020, Haryana: Talbros Automotive Components Limited would like to update on the following key business parameters of the Company for the quarter ended September 30, 2020:

- The company on standalone basis has achieved double digit Revenue growth over previous year same quarter, and has more than doubled its Revenue as compared to Q1FY21.
- All the Joint Venture businesses are at similar levels of Revenue in Q2FY21 as reported in Q2FY20. In September 2020, the Revenue growth of Joint Venture Businesses has seen a high single digit growth as compared to September 2019.
- The forging business has continued to perform well. It has attained a growth of over 30% in Q2FY21 compared to Q2FY20, which is the highest growth amongst all the product segments.
- Standalone Gasket business has grown by higher single digit as compared to Q2FY20 benefitting from the recent uptick in Domestic Automobile market.
- The Company has achieved major breakthrough by achieving maiden business for BSVI complaint Heat Shield product from two of the largest OEMs in Indian PV market.
